The Honorable Michael J. Butler was appointed to the Pima County Superior Court in May 2013 and has been assigned to the juvenile, criminal, and civil benches. During his time on the criminal bench, Judge Butler spent three years as Pima County's mental health judge and presided over all competency matters and the county's Mental Health Court.

Before his appointment, Judge Butler practiced as a commercial litigator in Tucson for 20 years. He earned his undergraduate and law degrees from the University of Arizona. Before pursuing his legal career, Judge Butler worked as a certified emergency paramedic.

The Honorable Michael P.
